General Provisions

- Per Sec.13.10 of the City of Becker Permit Applications; the Right of way permit application shall contain, and will be considered complete only upon compliance with, the requirements of the following provisions:
 - Registration with the city pursuant to this chapter
 - Submission of a completed permit application form, including all required documents, and drawings illustrating the location and area of the proposed project and the location of all known existing and proposed facilities: **HIGHLIGHT WORK ROUTE ON MAP/DRAWINGS**
 - Payment of money due the city for
 - Permit fees, and other management costs
 - Prior obstructions or excavations
 - Any undisputed loss, damage, or expense suffered by the city because of applicant's prior excavations or obstructions of the rights of way or any emergency action taken by the city
 - Payment of disputed amounts due the city by posting security or depositing in an escrow account an amount equal to at least 110 percent of the amount owing.

- Posting an additional or larger construction performance bond for additional facilities when applicant requests an excavation permit to install additional facilities and the city deems the existing construction performance bond inadequate under applicable standards.
- No facility shall encumber the first five (5) feet, as measured from the back of the curb. Fiber optic and copper facilities shall be placed at a minimum depth of 36" to the top of facility to a maximum depth of 48" to top of facility. Natural gas or electric shall be placed at a minimum depth of 24" to top of facility to a maximum depth of 48" to top of facility.
- Permittee agrees to conduct all work according to the City of Becker Right of Way Ordinance, along with all regulations to State Statutes and Rules.
- All work done under this permit shall be subject to City of Becker directions and shall be done to the satisfaction of the Public Works and Parks Assistant Director.
- City of Becker reserves the right to stop work at any time the terms of this permit are not deemed satisfactorily, and the city, at its discretion, may execute any of the work illustrated in the permit at the expense of the permittee.
- Should the installation restrict the definitive configuration of roadway construction, the permittee shall promptly relocate his installation at no cost to the city.
- The permittee must notify the City of Becker 24 hours prior to the execution of any work.
- No pavement can be removed or cut without permission from the City and road drainage must not be impeded.
- **Any blacktop or concrete replacement must be inspected by City staff prior to replacement. Please note the City requires a 24-hour notice for said inspection.**
- The permittee ensures that all areas surrounding this project be left in equal to or better condition than its existence prior to the beginning of the project.
